INDUSTRY NEWS

FCC Commissioner Jessica Rosenworcel's renomination to the Commission was the focus of comments made on the U.S. Senate floor this week, and it wasn't pretty. At issue is a gentleman's agreement between former Majority Leader Harry Reid and the Senator currently holding that post, Mitch McConnell. Reid took the fight to the floor and offered his perspectives that the Senate did Commissioner Mike O'Rielly's nomination several years ago without pairing the nomination with a Democratic nominee as is usually the custom, and that he was promised that Rosenworcel's re-upping would be afforded the same treatment. (Her term expired in June of last year, but she may serve until the end of this Congress). A spokesman for McConnell offered that the nomination has been moved out of committee, but that there are concerns from several Senators which are holding it up. Since she is still serving at the FCC, and her tenure does not end until the end of this session, the spokesman called Reid's barbs "disappointing."

CONGRESS

The FBI should have the resources necessary to access smartphones and not be forced to hire hackers to do it. So said several witnesses at a House Energy and Commerce Committee oversight and investigations subcommittee hearing on Tuesday. A review of the hearing appearing in a TRDaily article which excerpted comments from a Keystone State source, University of Pennsylvania professor Matthew Blaze. The professor noted that the bureau "either had – or devoted insufficient resources to – finding a solution" to the smartphone issue which was the focus of the San Bernardino terrorist investigation. FBI director James Comey said yesterday that the bureau paid more than \$1.3 million to gain access to the phone.
